Rules and Regulations: Please read carefully

Applications will be accepted beginning Friday, May 8, 2009.

Scoring and Judging:

1. Scoring is based on audience vote.
2. Audience will submit their votes at each performance.

Artists/Bands:

1. All artists must be at least 18 in order to participate.
2. Only the artists listed on your registration form may perform, you may include up to 2 alternates that can perform.
3. All members of each band/group are required to be present at least 30 minutes prior to their performance time.
4. Sunset Station Saturday Concert Series is a family-friendly event. Any artist wearing any clothing or items that refer to alcohol or other drugs or themes and is considered inappropriate by SSG concert manager will not be allowed to perform. When selecting your song set, keep in mind that this event is open to the public and you will be in front of a variety of people, we ask that you NOT use offensive language in your performance.
5. Anyone under the influence of alcohol or any illegal substance will be immediately disqualified and removed from the premises. Any use of illegal substances will not be tolerated and would immediately disqualify your entry in the contest.
6. Upon entry, bands are granting permission for their live performances to be recorded for promotional and distribution purposes by Sunset Station Group L.L.C.
7. Any special effects must be approved by the concert manager at least 72 hours in advance. The request must be made in writing. No fire or pyrotechnics of any kind will be permitted.
8. S.S.G. LLC reserves the right to disqualify any artist (s) for any reason.

Equipment:

1. All bands must be self contained. Sunset Station will NOT provide any equipment. Any connections to SSG grounds will be monitored for safety by SSG maintenance department.
2. All artists must bring all of their own gear and instruments.
3. Plaza stage has usable space of: 12 ½ ft. wide x 14 ½ ft deep and 2 ½ ft high.
4. Artists should keep in mind that 10 minutes are allotted for setting up and tearing down between sets so plan accordingly.
5. Contestants will need to sign a waiver of liability to Sunset Station Group prior to performing.

Prizes:

1. Grand Prize: \$2500 cash, headlining your own show on the Lone Star Pavilion stage with full "Star" treatment including a green room, dinner and full production concert.
2. Artists are encouraged to bring merchandise, CDs, supporter cards to promote their band and encourage their fans to vote for them.
